SHOOTING.

An unfriendly feeling has existed for a long time between C.W. Evans and George Steele. They each have a bunch of cattle that run on the Hackberry. Evans claims cattle from Steele's herd got onto his premises and damaged his crops. He "cut out" several head and herded them with his own and refused to surrender them. The cattle were the property of Mr. Haicks who is also a neighbor. The grounds where the cattle were taken from was measured and found to belong to Steele and the party measuring the land went out on the prairie where Evans' boy was herding and cut out the cattle and started for Steele's herd. Evans saw them and mounted a horse and started to intercept them and drive the stock back. He headed them and was turning them back when Steele rode up to him and, from the movements of Evans, thought that he was trying to draw his revolver and began trying to knock him off his horse with his fist before he could draw it. He struck twice and then saw that Evans had the gun out. Not being armed he whirled his horse to run just as Evans fired and received the ball in his left arm just below the shoulder making an ugly flesh wound and tore through the top of his left hand and out of the finger next to the little one, a second shot was fired that passed through the mare he was riding that caused her

death in a few hours. Steele's arm was corded and he was rapidly driven to town and Dr. Keeney dressed the wounds and he is getting along nicely. The shot was evidently aimed to kill and would have done so had it been four inches further to the right. Evans started to town to surrender and was met by deputy sheriff Zeigler and brought in. He was taken before Squire Camp and waved an examination. Bail was fixed at the ridiculously low figure of \$600. This has been approved and he will probably go before the next term of the district court for trial.

After this address, a tin box containing a brief history of the town, a copy of the Declaration of Independence, a charter of the Pioneer Town Co., plat of the town and names of the officers, a map of Kansas, copy of Logan County RECORD, Topeka Commonwealth, Winona Messenger, and the name of the Master Workman, (Geo. D. Kerns) was placed in the stone, and it was cemented and set.

It is rumored that Will Stratton, formerly of this place, was arrested at Hoxie, a few days ago, for playing U.S. Marshal and collecting revenue from some person who had been selling tobacco without license

J.S. Turner, Linkville, Missouri, bought the doublestore building on the west side of Grand now occupied by the OK Restaurant and the Millinery Store and other property.

Grace Armstrong, sister of cashier J. Armstrong, is clerking in the Bank of Russell Springs.

Russell Springs Record September 1, 1887

The count on the census has vote: Russell Springs-542 & Logansport-273 for the county seat. Russell Springs wins by 269.

The lake is filling up with water. The school house is enclosed, and walls of the courthouse rising rapidly.

B.F. Cannon has sold his flour and feed store to G.W. Landreth.

W.O. Disney arrived in Russell Springs. H.D. Jett is manager of Simpson, Disney, & Co. and W.D. Vernon left for his home in Pennsylvania. He had been co-manager at Simpson, Disney, & Co. The Post Office is now in the front of the store and lock boxes have been put in.

ACCIDENT.--Last Sabbath, August 21, Mr. J. H. Pemberton, of 26-36-15, met with a serious injury by the accidental discharge of a 44 caliber Sharps rifle. He was holding the gun in such a manner that when discharged the ball entered his body near the posterior part of the upper third of the thigh, fracturing the bone. Dr. Royce was called and dressed the wound. Should Mr. P. recover he will probably be a cripple for life.

DIED.-- Aug. 26, '87, of fever and paralysis of the heart, Geo. W. Harvel, aged about 22 years. His remains were taken to the railroad Saturday, and forwarded to his parents, at Raymond, Illinois.

Russell Springs Record September 1, 1887

Wednesday, a slight ripple for an instant disturbed the quiet of Russell Springs. It seems that a character known as Jersey, has for some time been bootlegging anti-prohibition drinks around town and, of late, has been too indiscriminate as to whom he sold the same. Some of the law-abiding people had been watching for evidence against him, as we don't want and wont have this kind of work in Russell Springs. On Wednesday, John Hill, having conclusive evidence that Jersey was not only selling liquor but was selling it to young boys, was so stirred up with righteous indignation that he at once proceeded to inflict sumnary punishment upon the person of Jersey. Having, in a measure, assuaged his wrath by this means he proceeded to hunt up Justice Fleming and Attorney Davis and get out a warrant for the arrest of Jersey, which was placed in the hands of Mr. Wright, but before it could be served the worthy had hied away, no man knoweth where. We warn bootleggers, gamblers, etc., that it is not safe to attempt their practices in this town.

Dr. Royce will soon be found in his new office west of the Logan House.

Dr. Crawford's residence is enclosed and will soon be ready for occupancy.

A. Chitwood has purchased the general merchandise stock of H. Morley and is building a 22'x60' store on the lot south of the Morley building.

Russell Springs is without a doubt one of the best trading points in Logan County. Last Saturday, there were 108 teams counted on the streets at one time.

In excavating at the spring, this week, B. McMillan found a pocket compass and an old-fashioned hatchet 5 feet under ground and in a good state of preservation.

J. H. Goodman, the blacksmith, sold his residence to G.W. Landreth for \$700. Mr. Goodman will now build a neat and commodious residence on his lots on the north side.

DIED.-- September 4th, 1887, at Russell Springs, Kansas, after an illness of thirty-one days, of typhoid fever, Forest W. Moore, aged 21 years and 20 days. He was born in Russell, St. Lawrence Co., N.Y., August 14, 1866. He came to this place last April with Mr. & Mrs. John Hill and lived with them. The services were conducted at the home of Mr. Hill, by Rev. McVeigh. His body was followed to its last resting place by the longest procession ever seen in Logan County.

> Russell Springs Record September 15, 1887

The great reservoir south of town that has been in process

of construction for the past month, is now completed. This has been a very heavy job of work with many obstacles in the way, but through the untiring energy and perseverence of Foreman McMillan the work was pushed to completion. The reservoir takes in an area of one hundred feet in width and two hundred feet in length, taking in three distinct springs. There is now ten feet of water, in depth.

Logan County Times September 29, 1887

J.R. Childers, of Stafford county, on Wednesday, began the foundation for a store on the second lot east of the post office. He will open a flour and feed store.

Frank Parsons is building a nice residence west of the church. The residence of Mr. Phinney, east of town is nearing completion.

Logan County Leader October 6, 1887

The people of Russell Springs will soon have a grand place to fish. Last week James S. Warden had about 200 carp shipped out from Frankfort, Kansas, and put them in the lake and reservoir.

The First National Bank Building is being pushed rapidly to completion. When finished it will be two stories, and one of the finest buildings in the Hub. The office of the president of the town company will be in the rear room of the building, fronting on Vine St. Logan County Times October 20, 1887

The Logan County Times has bought the Russell Springs *Record*. E.C. Forney retires from the *Record*. The Times and *Record* will consolidate, making one of the best papers in Western Kansas.

In rounding a short turn in the bluffs he saw the viscious thing rise, not ten feet from him, to spring, and jumped back, exchanged the babe for the gun and returned. Again the cat raised to attack him, and received the contents of the gun in the jugular vein, but sprung falling at Mr. Walruth's feet struggling to get at him and only ceased when life was extinct. Had Mr. W. not noticed him just as he did. himself or the babe would have been fearfully torn and perhaps killed.
